He was over the age of 21, an ESL student, from a single-parent family with seven siblings, raised in a foster home, first-generation college student, full-time employed, living independently, and a member of the [Nevada Army National Guard](#).

In the Army National Guard, he was a Crew Chief for the CH47-D Chinook helicopter (MOS 67U). He completed his Advanced Individual Training at Fort Eustis, VA on top of his class and earned recognition as "Distinguished Honor Graduate". During his military career he received various awards including the ArmyService Medal and Nevada Commendation Medal for Meritorious Service.

At the same time, he became the first minority President of a [Greek organization](#) on a predominately white campus. He was also every involved on and around campus, from student government to university hiring committees. Eventually, he was awarded with a certificate of recognition by the Board of Regents for his contributions to UNR and nominated for "Who's Who in American Colleges and Universities".

After he received a Bachelor of Science in Finance, with a minor in Economics from UNR, he attended [Rutgers School of Law-Newark](#) where he earned his Juris Doctorate in 2004. During his time at Rutgers he was an editor of the [Race and the Law Review](#), a facilitator for the [Minority Student Program](#), and clerked for the New Jersey Superior Court.

After passing the Bar exam in California, he participated as a Project Attorney on various largescale litigations involving issues from anti-trust, IP and Medicare fraud. He also works pro bono through Public Counsel for the Federal Bankruptcy Court advising indigent debtors during bankruptcy proceedings.
