Students overall did well with the case briefs. Students, in general, have some problems in distinguishing the Legal Issues of the case from the Legal Reasoning or Rationale.
- 3. <u>Summarize</u> what changes have been made or are planned to be made as a result of the assessments. To address the issue of confusion between issue and rationale, the entire paralegal/law discipline will adopt a new pedagogy of "paraphrasing case statements" see attached sample of Law 1

    - (a) Have the recommended changes been implemented? Previous SLOS in our law classes called for use of more videos. **The paralegal program is adopting the**

use of short videos through the implementation of zoom.us video service as provided through confernow.org Videos have been implemented in Law 1 and 10, and will be expanded to Law 19 and 16 during Spring 2016, and faculty will be trained in how to use zoom videos. Once Canvas is adopted in Fall 2016, all faculty will have easy and ready access to ConferNow and recording videos

Student success has increased with the use of videos, more prompt feedback from our online faculty, instructions for assignments improved, complete, and confusions clarified by more accurate instructions, and discussion forums updated with current topics, and inaccurate or broken links corrected
